

BEWARE OF FRAUDSTERS

ATTENTION STUDENTS & PARENTS

1. Sumandeep Vidyapeeth an Institution Deemed to be University has been receiving inputs from many students, parents, media and other sources that some individuals/agents/fraudsters/consultants are fraudulently promising admission at Sumandeep Vidyapeeth claiming to be associated with the university and claiming that they know top officials / higher authorities and they can get them admitted to various courses offered in Medical, Dental, Physiotherapy, Pharmacy, Nursing and Management.
2. Further, fraudsters are demanding money in the name of Sumandeep Vidyapeeth and issuing fake admission documents and/or fee receipts to which many of the students and parents are falling victims and are being duped.
3. Sumandeep Vidyapeeth brings to the notice of all the students and their parents who are aspiring to take admission in Sumandeep Vidyapeeth that it has not appointed/nominated any individual/agent/consultant/s etc., to carry out admissions on behalf of Sumandeep Vidyapeeth Deemed to be University.
4. The admissions for MBBS, BDS, MD, MS, PG Diploma & MDS are being done by Directorate General of Health Services (DGHS), Ministry of Health & Family Welfare, Govt. of India- Medical Counseling Committee (MCC) as per the orders of Hon'ble Supreme Court of India, MCI & DCI etc.
5. The counseling and admission for MBBS & BDS programs for the Academic Year-2018-19 at S.B.K.S. Medical Institute & Research Centre & K.M.Shah Dental College & Hospital respectively under Sumandeep Vidyapeeth Deemed to be University are being done by Directorate General of Health Services (DGHS), Ministry of Health & Family Welfare, Govt. of India- Medical Counseling Committee (MCC). To be eligible to take admission for MBBS & BDS the student has to register himself /herself on MCC website www.mcc.nic.in. The merit preparation and seat allotment is done by DGHS-MCC. The DGHS-MCC uploads all the information regularly on their website www.mcc.nic.in. It is appealed that students & parents visit official website www.mcc.nic.in on daily basis.
6. The admissions for BPT, MPT, BSc (N), MSc(N), PBBSc (N), ANM, GNM & NPCC; B Pharm, M Pharm, Pharm D, Pharm D(PB); MBA (Health Care) at Sumandeep Vidyapeeth Deemed to be University are done as per the guidelines given by the Statutory Bodies and UGC and admissions are done on the basis of merit scored at All India Common Entrance Test (AICTE) or (On the basis of merit prepared out of marks scored at qualifying examination when the number of applications for AICTE are equal to or less than that of number of seats approved for that course). The procedure of admissions is notified from time to time on website www.sumandeepvidyapeethdu.edu.in and that will be the final.
7. Sumandeep Vidyapeeth has established help desk at Admission Cell and responsible officers are made available with their contact number & E-Mail ID for appropriate and genuine guidance. The authentic information is uploaded on website www.sumandeepvidyapeethdu.edu.in. Students & parents are requested to visit the official websites given above. The information given on any other website other than official website mentioned above is either incomplete, wrong, distorted or completely fraudulent.
8. If any student/parent get in touch with fraudsters / Agents/ Consultants and use them for admission at Sumandeep Vidyapeeth Deemed to be University, they are doing it at their own risk and are only solely responsible for the same.

9. The Sumandeep Vidyapeeth Deemed to be University shall not be responsible and liable in any manner for any of the admission related matter including fraudulent admissions done by students/parents through agents/consultants etc.

Further, If anyone/any group/any company is found to be indulging in misusing the name of Sumandeep Vidyapeeth Deemed to be University fraudulently and misleading students / parents / general public for the purpose of admission or otherwise, Sumandeep Vidyapeeth Deemed to be University shall initiate legal action/s whatsoever deemed fit against all those involved.
