## NOTIFICATION

In exercise of the powers conferred by sub-section (2) of the section 11 of the Indian Medical Council Act, 1956 (102 of 1956), the Central Government, after consulting the Medical Council of India, hereby makes the following further amendments in the First Schedule to the said Act, namely:-

II) against "Sumandeep Vidhyapeeth, Vododara", under the heading 'Recognized Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

DM (Neurology)

(This shall be a recognized medical qualification when granted by Sumandeep Vidhyapeeth, Vododara in respect of students being trained at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara on or after 2017).

III) against "MGM Institute of Health Sciences, Navi Mumbai", under the heading 'Recognized Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry we lating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Doctor of Medicine (Geriatrics)"

MD (Geriatrics)

(This shall be a recognized medical qualification when granted by MGM Institute of Health Sciences, Navi Mumbai in respect of students being trained at MGM Mission's Medical College, Navi Mumbai on or after 2017).

## Note:

1. The recognition so granted shall be for a maximum period of 5 years from the date of notification, upon which it shall have to be renewed.

2. The procedure for 'Renewal' of recognition shall be same as applicable for the award for recognition.

3. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Postgraduate Courses.
