NOTIFICATION

S.O.... In exercise of the powers conferred by sub-section (2) of the section 11 of the Indian Medical Council Act, 1956 (102 of 1956), the Central Government, after consulting the Medical Council of India, hereby makes the following further amendments in the First Schedule to the said Act, namely:-

In the said Schedule:-

- a) against "**Sumandeep Vidyapeeth, Vadodara**", under the heading 'Recognized Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Magister Chirurgiae (Cardio Thoracic & Vascular Surgery)"	M. Ch. (CTVS) (This shall be a recognized medical qualification when granted by Sumandeep Vidyapeeth, Vadodara in respect of students being trained at Smt. B K Shah Medical Institute & Research Centre, Vadodara on or after 2019).

- b) against "**The Tamilnadu Dr. MGR Medical University, Chennai**", under the heading 'Recognized Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Magister Chirurgiae (Paediatric Surgery)"	M.Ch. (Paediatric Surgery) (This shall be a recognized medical qualification when granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at PSG Institute of Medical Sciences & Research, Coimbatore on or after 2019).
"Master of Surgery/Doctor of Medicine (Obstetrics & Gynaecology)"	MD/MS (OBG) (This shall be a recognized medical qualification when granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at ESI-PGMISR, Chennai on or after 2014).

c) against "West Bengal University of Health Sciences, Kolkata", under the heading 'Recognized Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Doctor of Medicine (Neonatology)"	DM (Neonatology) (This shall be a recognized medical qualification when granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at Institute of Postgraduate Medical Education & Research, Kolkata on or after 2014).


d) against "Aryabhatta Knowledge University, Patna", under the heading 'Recognized Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Diploma in Tuberculosis & Chest Disease"	DTCD (This shall be a recognized medical qualification when granted by Aryabhatta Knowledge University, Patna in respect of students being trained at Patna Medical College, Patna on or after 2017.)

Note:

1. The recognition so granted shall be for a maximum period of 5 years from the date of notification, upon which it shall have to be renewed.
2. The procedure for 'Renewal' of recognition shall be same as applicable for the award for recognition.
3. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the concerned Postgraduate Courses.
