Anti-Ragging measures taken by S.B.K.S. Medical Institute & Research Centre, Piparia

Anti-Ragging measures taken by S.B.K.S. Medical Institute & Research Centre, Piparia, a constituent medical institute of Sumandeep Vidyapeeth University, Piparia, (Taluka-Waghodia, Dist. Vadodara) is committed to prevent Ragging in the university campus and provide "Ragging Free" environment to the students and the environment conducive for learning.

Achieving the same the institution has initiated following measures, as per the guidelines provide by the Medical Council of India in its circular No: MCI-34 (1)/2009-Med./31046, dated 21st August 2009.

- VIII. Mentors have been identified from the teaching staff who remain in touch with the student of first and second year MBBS and help in preventing such incidents in the college. (Annexure 6)

- Dr. M. M. Sattigeri, Member Secretaryread out the internal Inquiry report with respect to Anti Ragging Complaint against students studying in Third year Part II MBBS 3rd YearMr. Kakkan Israni by Mr. Hetarth H. Thakkar, MBBS 3rd Year Part I Student.
- Once the inquiry report was reviewed the students were called one by one before the committee.
- First Mr Hetarth H Thakkar, the complainant was called. He was made comfortable by the Chairman with due assurances. He was asked to narrate the whole incident.
- Mr. Hetarth H. Thakkar, MBBS, 3rd Year Student stated in front of the University Anti Ragging Committee that he is feeling Safe and Secure. Further, he had informed to his parent regarding

the quarrel due their personal issues with Mr. Kakkan Israni, MBBS, a Final year student. The issue is also sorted out with his senior Mr. Kakkan Israni and he made him his friend and such type of re-occurrence will not happen in the near future. He submitted that it was a quarrel over personal issue and not a ragging. Under the enragement, he complained to Anti Ragging Help

- Police ASI, Waghodia Police Station Vadodara Gujarat Mr.R. M Patil, asked to Mr. Hetarth H. Thakkar, whether what he is telling under any kind of a pressure or threat of anykind. To this Mr Hetarth told freely that his statement is without any fear and pressure. And he is ready to submit letter stating what he is saying before the committee for resolving the matter. Mr. Hetarth H. Thakkar also told him that he want to withdraw any complaint against Mr. Kakkan Isranifor resolving the personal issues and he is ready to submit letter without any fear
- or threat. And this he also discussed with his parentsand they agree with what he is doing. Mr. Kakkan Israni, MBBS, a Final year student was summon by the University Anti-Ragging

Mr. Kakkan Israni stated that it was misunderstanding between him and Mr. Hetarth H. Thakkar. Further, it was a normal issue. Now both are friends and sorted out the issue nicely.

Police ASI R. M Patil, asked toMr. Kakkan Israni whether he had gone to the complainant and threatened him? To this Mr Kakkan said that it is Mr Hetarth who had visited him just before the quarrel. There afterwards Mr Hetarth and another friend came to library where he was studying and asked him to come out of the library and the heated arguments taken place.

Further, Police ASI R. M Patil advised to Mr. Kakkan Israhi to concentrate on studies and to avoid such type of incidences in future.

Both the involved Students Mr. Hetarth H. Thakkar and Mr. Kakkan Israni as agreed submitted withdrawal and apology letter respectively.

Chairman asked if any members wish to ask any question to either complainant and MrKakkan. To this members said they had no questions and matter is clear.

Recommendations:

- 1. As the episode is of the personal scuffle both the individuals must be issued serious warning and conveyed that they shall not engage in future in any such incidences.
- 2. Inform the UGC/ MHRD help line the findings of the inquiry immediately.

Conclusions:

The committee having deliberated on the matter after interrogating both the students is of the firm opinion that it is a case of minor scuffle and is not a case of ragging.

The meeting was concluded by the Chairperson at about12:10 hours. Further, Chairperson greet with votes of thanks to all the University Anti-Ragging Committee members.

WHAT IS RAGGING?

"UGC Regulations on curbing the menace of Ragging in Higher educational Institutions, 2009"

Any conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

INSTRUCTIONS TO FRESHERS

- 1. You do not have to submit to ragging in any form.
- 2. You do not have to compromise with your dignity and self-respect.
- 3. You can report incidents of ragging to the authorities concerned.
- 4. You can contact any member of the Anti Ragging Squad / Anti Ragging Committee of the College, or the Principal.
- 6. If you are not satisfied with the enquiry conducted by the College, you can lodge a First Information Report (FIR) with the local Police, and can complain with the civil authorities also.
- 7. The college is in any case required to file FIR if your parents or you are not satisfied with the action taken against those who 'ragged' you.
- 8. Your complaint can be oral or written, and would be treated by the authorities in strict confidence.
