1. That, I am residing at above mentioned address.
2. That, I belong to Jain religion by birth.
3. That, I belong to Jain Minority community which is included in notified minority communities under Section 2(C) of the National Commission for Minorities Act, 1992, by the Government of India.
4. That in support of my statement, I am enclosing copies of following documents with the present affidavit
 - A. Jain Minority Certificate issued by State Government or any statutory authority
 - B. Jain Minority Certificate issued by local religious Jain Sangh
 - C. School leaving certificate of self-mentioning religion as Jain
 - D. School leaving certificate of my Father/ Mother mentioning religion as Jain
 - E. Any other:
5. That I have opted for admission under Jain Minority Category for **«Doctor of Medicine (M.D.) / Master of Surgery (M.S.)** in **«Name of Branch»** during the Academic Year 2020-21 at Sumandeep Vidyapeeth, an Institution Deemed to be University, At&Post Piparia, Ta. Waghodia, District Vadodara, Gujarat, being fully aware that by doing so I abide by all the terms and conditions defined therein.
6. That, I am fully aware of the fact that, as I am taking admission under Jain Minority category, as per the regulations of the Sumandeep Vidyapeeth, I will have to submit
 - a) Undertaking for Future Fees &
 - b) Service Bond of one year of posting at a place which will be purely at the discretion of the Sumandeep Vidyapeeth.

In that case, I shall have to follow the other terms and conditions of the "Undertaking" and "Service bond" including the penalty clause.

7. I fully understand that after accepting admission in Jain category, change in category of admission shall not be permitted, as that undermines merit and shall attract the same penalty as breach of conditions of the "Service Bond" as stated in the bond.
8. That, I am fully aware and agree to the fact that my admission will be cancelled, if any time in future, it is found that false information has been submitted or wrongly represented by me or the documents submitted by me at the time of admission were found to be fraudulent / forged or I have made fraudulent claim of belonging to Jain Minority Community.
9. That, I am fully aware and agree to the fact that due to any reason, whatsoever, if I discontinue the course after getting the admission or being made to leave the course on account of indiscipline or misconduct or in the event of cancellation of my admission due to circumstances mentioned in clause (8) above, I shall be liable to the conditions mentioned in "Undertaking for Future Fees" and "Service Bond" submitted by me at the time of admission.

I understand and agree that Sumandeep Vidyapeeth can initiate any appropriate legal procedure for the recovery of entire outstanding amount against me.
