7. That I am fully aware and agree to the fact that my admission will be cancelled if any time in future it is found that false information has been submitted or wrongly

represented by me or the documents submitted by me at the time of admission were found to be fraudulent / forged or I have made fraudulent claim of belonging to Jain Minority Community.

That I am fully aware and agree to the fact that due to any reason whatsoever if I discontinue the course after getting the admission or being made to leave the course on account of indiscipline or misconduct or in the event of cancellation of my admission due to circumstances mentioned in clause (7) above, the cheque/s submitted by me or my father/ mother/ guardian in lieu of security for payment of tuition fees for balance years, shall be encashed by Sumandeep Vidyapeeth and in that case I shall also be liable for additional penalty of :-
- a. Sum of Rs. 2,00,000/- and
  - b. Sum equivalent to the difference of fees between the fees prescribed for the Management category seats and the Minority Category seats along with interest of 12% per year from the date of admission till the date of payment
