That I am fully aware and agree to the fact that my admission will be cancelled, if any time in future it is found that false information has been submitted or wrongly represented by me or the documents submitted by me at the time of admission were found to be fraudulent / forged or on account of indiscipline or misconduct on my part amounting to cancellation of admission as per the regulations of Sumandeep Vidyapeeth.

I hereby agree & undertake to pay the total fees of the entire course without any demur, in the event of cancellation of my admission due to circumstances mentioned in clause (8) above or for any reason whatsoever or in the event of failing to pay fees in-time or leaving the course after counseling period or during middle of course, as the seat remain vacant after the last date of the admission.  - c. Penalty of sum equivalent to the difference of fees between the fees prescribed for the Management category seats and the Minority Category seats along with interest of 12% per year from the date of admission till the date of payment

I understand and agree that Sumandeep Vidyapeeth can initiate any appropriate legal procedure for the recovery of entire outstanding amount against me.
