## MBBS/BDS Admission 2020-21

### Regulations for Withdrawal / Resignation from Admission

SCENARIO	PENALTY
<p><b>Scenario A:</b> The candidate who is allotted MBBS / BDS seat at Sumandeep Vidyapeeth by MCC (during round 1 or round 2) and has completed the admission process, resigns from the admitted seat <u>within twodays of Round-2 result announcement</u></p>	<ul style="list-style-type: none"><li>▪ Rs 10,000/- (Rupees ten thousand) will be deducted from the Tuition fees paid by the candidate at the time of admission.</li><li>▪ Remaining amount will be refunded within 7 working days.</li></ul>
<p><b>Scenario B:</b> The candidate who is allotted MBBS / BDS seat at Sumandeep Vidyapeeth (during any round) and has completed the admission process, resigns from the admitted seat anytime <u>after two days of Round-2 result announcement</u></p>	<ul style="list-style-type: none"><li>▪ Please note that as per regulations of Medical Counseling Committee, cancellation of admission is not permissible anytime after twodays of Round-2 result announcement.</li><li>▪ Even then, if the candidate resigns/ leaves the course, he/she is liable for penalty as below(a+b+c):<ol style="list-style-type: none"><li>a) Forfeiture of entire fees paid at the time of admission</li><li>b) The unconditional bank guarantee or undated security cheque/s deposited by the candidate at the time of admission in favor of Sumandeep Vidyapeeth Deemed to be University for the payable amount will be encashed by the Institution. The Sumandeep Vidyapeeth will have authority to recover the entire penalty amount by appropriate legal procedures.</li><li>c) For Jain Minority Category candidate admitted in MBBS, he/she is also liable for terms and conditions mentioned for breach of service Bond. Hence the additional penalty will be as below:<ol style="list-style-type: none"><li>i. Rs.10,00,000/- (Rupees Ten Lakh) as penalty for breach of Service Bond <b>plus,</b></li><li>ii. Candidate will have to pay the amount equivalent to the difference of fees between the fees prescribed for Management category seats and the Jain Minority seats along with interest of 12% per year from the date of admission till the date of payment.</li></ol></li></ol></li></ul>
