### **Subject: Stray Vacancy Round for MBBS and BDS Admission 2020-21**

The Stray Vacancy Round for the Admission in the vacant seats for MBBS and BDS programs, at Sumandeep Vidyapeeth Deemed to be University, will commence from 7<sup>th</sup> January 2021, as per the guidelines published by Medical Counseling Committee (MCC), Directorate General of Health Services (DGHS), Government of India, New Delhi.

The available Seat matrix for Stray Vacancy Round shall be as under:

#### **1. Eligibility Criteria:**

##### **A. For Management Category -**

The name of the candidate should be listed in ***“Eligible candidate list for participation in Stray Vacancy Round”*** published by MCC.

##### **B. For Jain Minority Category -**

The eligible candidate shall belong to Jain Religion, and should be listed in ***“Eligible candidate list for participation in Stray Vacancy Round”*** published by MCC.

##### **C. For NRI Category -**

The name of the candidate should be listed in ***“Eligible candidate list for participation in Stray Vacancy Round”*** published by MCC and ***“Eligible Candidate list for INDIAN to NRI”*** published during previous rounds i.e. Round 1 / Round 2 / MOP UP Round by MCC.

#### **2. Change of Category:**

**In case, if the name of the candidate is not listed in the “Eligible Candidate list for INDIAN to NRI”** published by MCC during previous rounds i.e. Round 1 / Round 2 / MOP UP round and the candidate is claiming to be NRI as per the directions / orders of Hon'ble Supreme Court of India in the case (W.P. (C) No.689/2017- Consortium of Deemed universities in Karnataka (CODEUNIK) & Anr. Vs. Union Of India &Ors.) dated 22-08-2017, such candidate should send the relevant documents as mentioned below, in support of claim of change of Nationality from Indian / Other to NRI through e-mail to [admission@sumandeepvidyapeethdu.edu.in](mailto:admission@sumandeepvidyapeethdu.edu.in) latest by **Thursday 7<sup>th</sup> January 2021, up to 5:00pm**. The e-mails received beyond 5:00 pm will not be considered for conversion of category from Management to NRI. The documents of all



such candidates will be sent by Sumandeep Vidyapeeth Deemed to be University (SVDU) to MCC for ascertaining the eligibility for the NRI category. Only after obtaining the approval from MCC, the candidate will be allotted NRI seat, as per the merit and as per the availability of seat.

The lists of documents to be sent through e-mail are as follows:

- a. Documents claiming that the Sponsorer is an NRI (Passport and Visa of the Sponsorer).
- b. Relationship of NRI with the candidate as per the court order of The Hon'ble Supreme Court of India in W.P.(c) No. 689/2017- Consortium of Deemed Universities in Karnataka (CODEUNIK) & Ans. Vs Union of India & Ors. dated 22-08-2017.
- c. The duly notarized Affidavit from the Sponsorer that he/ she will sponsor the entire course fee of the candidate.
- d. Embassy Certificate of the Sponsorer (Certificate from the Consulate).
- e. NEET Score Card of the candidate.
- f. Affidavit before Judicial Magistrate First Class (In prescribed format)

### 3. Admission Process at SVDU:

- i. All candidates who are eligible and interested to participate in Stray Vacancy Round of SVDU, shall download the 'Application Form' from [www.sumandeepvidyapeethdu.edu.in](http://www.sumandeepvidyapeethdu.edu.in)
- ii. The candidate who is applying for admission in MBBS program, shall pay refundable security deposit of Rs. 25,000/- along with the Application Form. The Refundable Security Deposit shall be remitted only through RTGS/ NEFT/ IMPS to the following Bank Account of the Institution **before 3:00 pm of 8<sup>th</sup> January 2020:**

- iii. The scanned copy of duly filled 'Application Form' along with the necessary enclosures shall be mailed to [admission@sumandeepvidyapeethdu.edu.in](mailto:admission@sumandeepvidyapeethdu.edu.in) up to **Friday 8<sup>th</sup> January 2021, upto 5:00pm.**
- iv. The Application Form will be rejected in following cases –
  - a. If received beyond 5:00 pm of 8<sup>th</sup> January 2021.
  - b. If Refundable Security Deposit is not paid.
  - c. Incompletely filled Application Form.
- v. The Application Form will be scrutinized by the Admission Committee of SVDU, for ascertaining the eligibility of the candidate.



- vi. The Inter-se-merit list will be prepared on the basis of 'NEET UG 2020 All India Rank' of the eligible applicants. The presence of candidate's name in the merit list does not guarantee Admission to MBBS / BDS program.
- vii. The schedule for Counseling for document verification and allotment of seats will be displayed on [www.sumandeepvidyapeethdu.edu.in](http://www.sumandeepvidyapeethdu.edu.in).
- viii. Physical presence of candidate along with original documents is must at the time of Counseling.
- ix. The candidate allotted seat in MBBS / BDS program shall have to compulsorily make the complete payment of applicable Educational Fees through Demand Draft only. The demand draft should be drawn in the name of "**Sumandeep Vidyapeeth Deemed to be University**" payable at Vadodara for the payable amount as per allotted category. It is advisable for all the aspirants to keep ready the Demand Draft for the payable amount keeping in view the banking holidays / National Holidays. Inability to pay the applicable educational fees at the time of admission may result in cancellation of allotted seat.
- x. At the time of Admission, the candidate shall submit
  - a. Legal undertaking for future fees.
  - b. Unconditional bank guarantees/ un-dated cheques in favour of 'Sumandeep Vidyapeeth Deemed to be University'.
- xi. Any dispute / legal conflict regarding admission shall be subjected to Waghodia Jurisdiction only.

#### **4. Forfeiture of Refundable Security Deposit:**

The candidate applying for admission in MBBS program shall deposit / pay the refundable security deposit of Rs. 25,000/- along with Application form. The Refundable Security deposit shall be remitted only through RTGS/ NEFT/ IMPS to the Bank Account of the Institution as specified above, **before 3:00 pm of 8<sup>th</sup> January 2020.**

The Security deposit will be forfeited in following conditions:

1. If the candidate is absent during the Counseling stage, as per the schedule.
2. If the candidate is allotted for admission during the Counseling stage, but he/she is not willing to secure the allotted seat, due to whatsoever reasons.
3. If the candidate provides wrong / misleading information, conceals information etc. in the Application Form.
4. If the candidate submits forged / false / tampered documents / credentials, in the Application Form.
