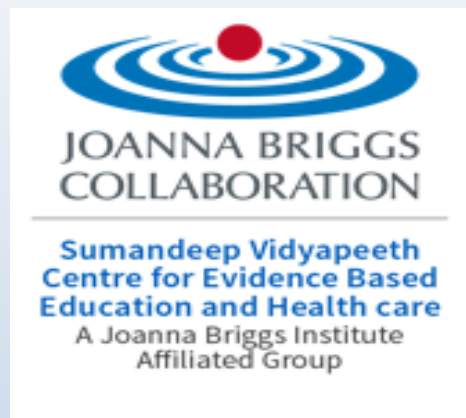

This was 5 day program which was held between 05-08-2019 to 09-08-2019. This program was conducted under 3 modules.

Module 1: Introduction to Evidence based Health Care and the systematic review of Evidence

Module 2: Conducting systematic reviews of Quantitative evidence.

Module 3: Conducting systematic reviews of Qualitative evidence and text & Opinion.

3rd International Conference on Evidence Based Education System (EBESCON 2019)

On 12th December 2019, the event started with pre-conference workshops. Total eight workshops was organized on various topics of EBP. Dr. Kameshwar Prasad presented his views on EBHC by his oration titled 'Impact of EBM on clinical practice: personal perspective'. Very effectively he narrated various cases and ways in which they used Evidence-based practice in their daily routine and how it affected their decision making for the best possible care of the individual patient. Dr. Ian Needleman spoke on 'Evidence- informed healthcare.' The delegates stuck to their chairs as he went through his lecture demonstrating the positive impact of practicing evidence-based healthcare on the decision making of the practitioner, the quality of care provided even with limited resources and the confidence built up among the patients with interesting real life cases from his own OPD. Lecture on 'Embedding ABCs of EBP in undergraduate health care students' was by Professor Ritin Fernandez. She started with the history of evidence based movement and how it progressed over time. She explained how they had integrated EBP in undergraduate curriculum with small but effective changes in their institution and the impact this process had on their students. Dr. Prabir Bandopadhyay delivered his keynote address on 'Evidence based mind-set is a prerequisite for Big Data-based decision making in Health care management'. The scientific deliberation was followed by scientific paper and poster presentations by delegates. On 14th Dec, lecture on 'Translating evidence into practice' was delivered by Dr. Pushpa Narayanswami. She narrated various ways in which evidence based concept can be used in daily practice and the advantages of doing so in a simple and understandable way. This was followed by a lecture on 'Creative Medical Classroom' by Dr. Anuradha Joshi and the last key note lecture was on 'Let's get UP TO DATE' by Dr. Raju Rhee. He gave an elaborate presentation on all the features of the app Uptodate. The panel discussion was on 'Evidence based health care practice - opportunities and challenges' which was moderated by Dr. J. D. Lakhani and the panelists were Dr. Kameshwar Prasad, Dr. Ian Needleman, Dr. Mona Shah, Dr. B. K Soni, Dr. Samip Sheth & Dr. Ami Shah.
