5. Community activities

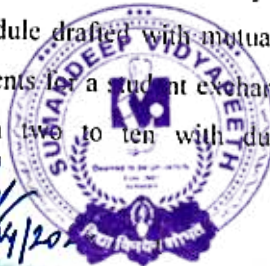
In order to execute the activity under the identified areas as listed above, a detailed blue print shall be generated upon consultation between both the parties. It is proposed to have

#### GENERAL AREAS OF COOPERATION:

- 1.1 Joint Educational activities including Evidence Based Dental Education.
- 1.2 Exchange of visiting faculty members for the purpose of education and training.
- 1.3 Discussion for the exchange of Postgraduate students for education and training.
- 1.4 Utilization of learning resource centre and knowledge exchange.
- 1.5 The financial implications and support to the program under this MoU will be as under: The travel from and to the venue shall be borne by the students enrolled for the exchange program. The financial implication towards a suited accommodation and food is to be borne by the University hosting the program.
- 1.6 The students enrolled for the program shall be given on duty leave/academic leave for the said days of the session inclusive of travel days after approval from competent authority.

#### ARTICLE II: THE AGREEMENT

- 2.1 Dept. of Public Health Dentistry, K.M. Shah Dental College and Hospital, Sumandeep Vidyapeeth, will be represented by Head of Department, Department of Public Health Dentistry, K.M Shah Dental College & Hospital and the Department of Public Health Dentistry; People's Dental College will be represented by respective Head of Department for the purpose of coordinating towards execution of the program.
