- 1. The applicants who are seeking migration from SBKSMIRC, SVDU to the other recognized Medical College in India shall pay complete / full education fees, for the remaining tenure of their entire course / program (that is upto 3rd MBBS Part - II) and shall submit 'No Dues Certificate' and the notarized 'Undertaking' in the prescribed format.
- 2. The applicants who are seeking migration from another recognized Medical College into SBKSMIRC, SVDU shall submit the 'Legal Undertaking' along with 'Unconditional Bank Guarantee' or 'Un-dated cheques' in favor of 'Sumandeep Vidyapeeth Deemed to be University' for the amount payable as tuition fees for the remaining tenure of the MBBS Program.
