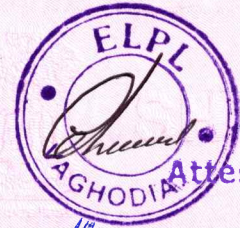

#### **2. Scope of the Collaboration**

The present MoU will be jointly conducted between SVDU and UTU with defined areas. The core objectives comprises of:

- A. Collaborative research by sharing their research facilities and writing collaborative research projects in the fields of engineering, pharmacy and science for Government funding.
- B. Teaching faculty and Student exchange programme in order to gain knowledge of Medical / Technology in lieu of developing either medical devices of some Artificial Intelligent based software or machine to provide the smart services to patients.
- C. To organize National and International conferences, seminars, workshops etc. at either of the places to disseminate the relevant knowledge to the participant significantly in the area of Nano-technology based formulations or devices.
- D. Collaboration with mutual interest, may conduct in-house trainings on various instrumentation and related activities for the faculties/Scholars involved in the project for smooth carrying out the research at both the organization.
- E. Collaborative publication of the preliminary research outcome &/or the final research outcome in peer reviewed journals.
- F. Collaborative submission of high end research projects to various Government / Non - Government funding agencies.



### 3. General Areas of Cooperation

Sumandeep Vidyapeeth Deemed to be University and UTU shall encourage interactions among Scientists, Clinicians, faculty members, Research fellows and students through the following arrangements:

1. Organize and deploy short term certified training programs on new approaches in Pharmaceutical Technologies,
2. Work on mutually acceptable projects including but not limited to field activities, organizing seminars and workshops on cutting-edge pharmaceutical research,
3. Propose research concepts/ ideas to any national/ international agencies for financial assistance/ development of innovative devices/ products,
4. Exchange of personnel through deputation as per the rules of the respective Institute, as mutually agreed upon,
5. Research supervisors from both the Parties will be the corresponding authors in any publication resulting from the collaborative work.
6. All the efforts put by the student/s as a part of this MoU will be accounted for by way of reporting the work in thesis and/or paper publication except the part for which IPR needs be claimed. Neither party will publish the work carried out under this MoU without knowledge of the other.
7. The Student Exchange program will be by mutual consent, between both the parties. The student may be provided with Hostel accommodation, if available. The travel expenses or any other expenses incurred by the student / visiting Institute during the exchange program, will not be borne by the host Institute.

### 4. Intellectual Property Rights

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both parties to this Memorandum. Both parties shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both parties shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the parties agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing. Any publication regarding such intellectual property shall only be possible with the prior written consent of both parties, such consent not to be unreasonably withheld.

### 5. Amendments / Modifications

This MoU may be amended or modified by a written agreement signed by the representatives of both parties.

### 6. Adherence to Laws

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the directives, regulations, guidelines etc. of the host Institute.







## 8. Jurisdiction


