This MoU is for establishing the collaboration between SVDU and NRCC, in the area of Research, Innovation and Development of Food and Nutritional products, Joint Programs/ Courses, Startups, Community / Social Service, Research on metabolic disorders, Collaborative Conferences/ Seminars/ Workshops etc. The collaboration between both the parties herein under, is based upon the principles of mutual interest.

1. Preamble:

Sumandeep Vidyapeeth Deemed to be University was notified through Gazette Notification of Ministry of Human Resource Development (MHRD), Department of Higher Education, Government of India, through vide notification No.F.9-46/2004-U.3 dated 17th January 2007, as 'Deemed to be University' under *de novo* category. With the decline in the traditional utility of camel for draught purposes, the Centre in now promoting camel as a dairy animal and focusing its research to validate the prophylactic/ therapeutic potential of camel milk in various human ailments that has drawn attention of scientists worldwide, though it is being used in folklore medicine since times antiquity in India. 2. Scope of the Collaboration:

The present MoU will be jointly conducted between SVDU and NRCC with defined areas. The core objectives comprise of:

- A. Will jointly conduct research studies not limited to Development of Food and Nutritional product.
- B. Collaborative research by sharing the research facilities and writing collaborative research projects in the fields of health sciences for Government funding.
- C. Teaching faculty and Student exchange programmes in order to gain knowledge in all the areas including Technology.
- D. To organize National and International conferences, seminars, workshops etc. at either of the places to disseminate the relevant knowledge to the participants and stakeholders, significantly in the area of healthcare sciences.
- E. To collaborate for conduction of in-house trainings on various aspects of health sciences for the teaching faculties, scholars and students.
- F. Collaborative publication of the research outcome in peer reviewed journals.
- G. Collaborative submission of high end research projects to various Government / Non - Government funding agencies, at National and International level.
- H. To facilitate work related to Doctoral and Post Doctoral programs.

3. General Areas of Cooperation:

This MOU details the modalities and general conditions regarding collaboration between the two Institutes, which shall encourage interactions among Scientists, Clinicians, faculty members and Research fellows of both the parties through the following arrangements:

3.1. Organize and deploy short term certified training programs.

- 3.2. Work on mutually acceptable projects including but not limited to field activities, organizing camps for spreading health awareness resulting into societal benefit and assist policy making in healthcare.
- 3.3. Both parties shall propose research concepts/ideas to any national/international agencies for financial assistance/ development of innovative devices / products / clinical trials and exchange of personnel through deputation as per the rules of the respective institute, as mutually agreed upon;
- 3.4. There will be no restriction on the contents of the research report and on publication of the results of the research study, subject to the condition that no Intellectual Property Rights (IPR) can be secured for any part of the work which will be decided with mutual consent.
- 3.5 If the outcome of a project related to product development, process technology and design etc. which involves matter of secrecy and concern with security of the State and the Country, the same will not be allowed for publication / printing in any form such as electronically/verbal, etc. If the outcome of a project results into an intellectual property, for which rights can be secured, it will be decided on case to case basis. Similarly, sharing of expenditure in securing such rights and income accrued through royalty etc. by the parties under the law will be decided on case to case basis after mutual consultation.
- 3.6. The Researchers from both the Parties, will be the authors in the publication/s, resulting from the collaborative work.
- 3.7. Neither party will publish the work carried out under this MoU without knowledge of the other.

4. Other Areas:

- To exchange information on research and educational programs,
- To exchange information on teaching, learning material and other literature relevant to their educational and research programs,
- To jointly organize short-term continuing education programs on topics of mutual interest and to invite each other's faculty to participate therein,
- To propose and engage jointly in research or training programs sponsored by funding agencies, and to invite each other's faculty to participate therein.

5. Exchange of Research Personnel:

- This MOU is intended, among other objectives, to foster increased interaction among faculty and advanced graduate students engaged in scientific and scholarly research in areas of mutual interest. In support of this effort, each party will promote the exchange of research personnel, especially young faculty and advanced graduate students, for short periods of time so that they may become familiar with the facilities, methodologies, research culture and concern area of cooperation.
- As a general principle, funding for the exchange of such personnel ("Participating Researchers") shall be based on a reciprocal sharing of costs:

Intellectual Property Rights (IPR):

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MoU shall be vested in both parties to this Memorandum. Both parties shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both parties shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes

Participating faculties, staffs and students involved in any activities under this Memorandum must adhere to the law of the host countries and rules and regulations of the institutions.

Legal effect:

Nothing in this Memorandum shall be construed as creating any legal relationship between the parties. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

Commencement and Tenure of MOU:

The present MoU shall become effective from the date of signing. It shall remain in force for the period of Five (5) years i.e. from 17th January 2023 till 16th January 2028. This MoU will be amended/ terminated with mutual consultations and written agreement, as and when needed.

Dispute Resolution:

Any dispute or difference arising out of or in connection with the interpretation or implementation of this MoU or out of or in connection with the breach, or alleged breach of this MoU, each Institution shall attempt in the first instance to resolve the conflict
