1. Preamble

1.1 About SVDU

Sumandeep Vidyapeeth, an Institution Deemed to be University (SVDU) was established under Section 3 of UGC act 1956. The Institution is conferred with Category-I Deemed to be University status by University Grants Commission (UGC). The Institution has various constituent Institutes like Department of Pharmacy, SBKS Medical Institute & Research Centre, K. M. Shah Dental College & Hospital, Sumandeep Nursing College, College of Physiotherapy, Department of Management, Department of Public Health and College of Rehabilitation Sciences. All these Institutes offer Certificate, Diploma, Undergraduate, Postgraduate, Doctoral (Ph.D.), Value Added Courses, Interdisciplinary programs in the disciplines of Health such as Medical, Dental, Pharmacy, Nursing, Physiotherapy, Healthcare Management, Paramedical, and Audiology & Speech Language Pathology. These programs are approved / recognized by Statutory Regulatory Authorities.

1.3 About AIC-LMCP

AIC-LMCP Foundation aims to be a catalyst in developing the incubation and start-up ecosystem in Gujarat by offering incubation facilities, central instruments facility, mentoring, facilitation of funding and support for Intellectual Property management to the aspiring entrepreneurs with novel ideas and innovative solutions in pharmaceutical and healthcare sector that can be commercialized. (hereinafter referred to as "AIC-LMCP" which expression shall wherever the context so claims include its members, successors and permitted assignees)

2. Scope of the Collaboration

SDVP, LMCP and AIC-LMCP acknowledge that this collaboration will cover following aspects:

- Academic, Research, Innovation, Incubation and Startup support, Education, Social Service, Health Service, Student / Teaching faculty Exchange program etc.
- 2. Joint Projects in the areas of Research, Innovation and providing technical and
- Mentoring support to incubatees / Startups incubated at AIC-LMCP.

3.General Areas of Cooperation

This MOU details the modalities and general conditions regarding collaboration between SVDU, LMCP and AIC-LMCP for enhancing **Research**, **Innovation and Entrepreneurship**, without any disregard to any mechanism evolved and approved by the competent authorities under Govt. of India, so far as such mechanism applies to SVDU, LMCP and AIC-LMCP. The areas of cooperation can be extended through mutual consent.

SVDU, LMCP and AIC-LMCP shall encourage interactions among Scientists, Clinicians, faculty members, Research fellows, students and incubatees through the following arrangements:

- 3.1. Organize and deploy short term certified training programs.
- 3.2. SVDU, LMCP and AIC-LMCP shall propose research concepts/ideas to any national/international agencies for financial assistance/ development of innovative devices/products/prototypes/ proof of concepts/exchange of personnel for training through deputation as per the rules of the respective institute, as mutually agreed upon;
- 3.3. Practical training of SVDU students at LMCP and AIC-LMCP.
- 3.4. LMCP and AIC-LMCP may depute its personnel as visiting faculty at SVDU to teach any of the specialized topics pertaining to the areas of cooperation.
- 3.5. LMCP and AIC-LMCP personnel, as well as research scholars, may also be allowed to carry out research pertaining to the areas of cooperation at SVDU, as per Institutional regulations.
- 3.6. LMCP and AIC-LMCP may seek assistance/guidance of SVDU faculty member/s in product/process modification, modernization, trouble shooting, etc.

- 3.7. LMCP and AIC-LMCP would allow the students to provide them with an exposure to various equipment, instrument, etc.
- 3.8. Visiting faculty/scientists/research scholars from LMCP and incubatees from AIC-LMCP may avail clinical/ pre-clinical facilities, laboratories, library, Internet, computational facilities and get access to required resources at SVDU.
- 3.9. A Researcher/faculty at LMCP and AIC-LMCP may be appointed as Co-guide as per the rules of the respective institute for a student Registered for Ph.D./PG degree at SVDU.
- 3.10. The UG /PG students may undertake research work or project at SVDU / LMCP / AIC-LMCP depending on the nature of the work, as per rules of the respective institute depending on facilities and requirements.
- 3.11. If the outcome of a project related to product development, process technology and design etc. which involves matter of secrecy and concern with security of the State and the Country, the same will not be allowed for publication/printing in any form such as Electronically/verbal, etc. If the outcome of a project results into an intellectual property, for which rights can be secured, it will be decided on case to case basis. Similarly, sharing of expenditure in securing such rights and income accrued through royalty etc. by the parties under the law, will be decided on case to case basis after mutual consultation.
- 3.12 SVDU will support the incubatees of AIC-LMCP with respect to access to subject matter experts for technical mentoring, access to various institutes of SVDU, laboratory facilities and resources for facilitation of their needs, based on the mutually agreed terms.
- 3.13. Individuals involved in the Research, from involved Parties, shall be included as authors in the publications arising out of this collaboration.
- 3.14. Neither party will publish the work carried out under this MoU without the knowledge of the other parties.
- 3.15. In case of any of the activities mentioned above, wherever financial aspects are involved, amount, payment conditions etc. would be spelt out clearly before starting the activity.

3.16. Student Exchange

- Selection of student(s)eligible under student exchange activity will be selected by mutual agreement between the parties
- Such student(s) will continue to be treated as full-time student at his/her home institution
 and as full-time "exchange" student at the host institution.
- His/her programme of study at the host institution will be determined by mutual consultation between his/her academic advisor at the home institution and his/her "interim" academic advisor identified by the host institution.
- The host institution will evaluate performance of such student(s) in each course or module, award grade or marks, and issue a letter to that effect.
- The home institution may award to such student credits earned at a host institution, but only after the home institution has established correspondence between courses taken at the host institution vis-a-vis those offered at the home institution.
- If such student has undertaken research, then the host institution will evaluate the student's performance, and issue a letter to that effect, together with a technical "report" of the research carried out.

- If such student has undertaken research, then the home institution will take note of the
 performance evaluation and the technical report, and take steps in accordance with its
 own procedures.
- SVDU, LMCP and AIC-LMCP may agree to provide suitable accommodation and living expenses for student exchange, as per the rules of the institute.
- To avail travel expenses, students can apply for existing funding programs at their respective home Institution / Universities.
- Such students will pay tuition and other fees at their home Institution / Universities, as applicable.

4. Confidential Information

SVDU, LMCP and AIC-LMCP will not divulge the confidential information during the collaborative research activity.

5. Intellectual Property Rights

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in by the parties to this Memorandum. The parties shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both parties shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the parties agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing.

Any publication regarding such intellectual property shall only be possible with the prior written consent of parties, such consent not to be unreasonably withheld.

6. Amendments/Modifications

This MoU may be amended or modified by a written agreement signed by the representatives of all the parties, as an when required.

7. Adherence to Laws

Participating faculties, staff, students and incubatees involved in any activities under this Memorandum must adhere to the regulations of the Institution.

8. Legal Effect

Nothing in this Memorandum shall be construed as creating any legal relationship between the parties. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

9. Commencement and Tenure of MOU

The present MoU shall become effective from the date of signing. It shall remain in force till the completion of the research project as well as continues association as per the activities. This MoU will be renewed after every Five (5) years of tenure while it will be amended/ terminated with mutual consultations and written agreement.
