Both Dhiraj Hospital, SBKSMIRC and Faculty of Family and Community Sciences shall encourage interactions among Scientists, Clinicians, faculty members, Research fellows and students of both the parties through the following arrangements:

- 3.1. Organize and deploy short term certified training programs.
- 3.2. Work on mutually acceptable projects including but not limited to field activities, organizing camps for spreading awareness on cancer prevention, screening, diagnosis, rehabilitation, health mapping and relevant research resulting into societal benefit and assist policy making in healthcare of Gujarat State.
 - 3.3. Both Dhiraj Hospital, SBKSMIRC and Faculty of Family and Community Sciences shall propose research concepts/ideas to any national/international agencies for financial assistance/ development of innovative devices/products/clinical trials and exchange of personnel through deputation as per the rules of the respective institute, as mutually agreed upon;
 - 3.4. Practical training of Dhiraj Hospital, SBKSMIRC at Faculty of Family and Community Sciences
 - 3.5. Faculty of Family and Community Sciences may depute its personnel as visiting faculty at Dhiraj Hospital, SBKSMIRC to teach any of the specialized topics pertaining to the areas of cooperation
 - 3.6. Faculty of Family and Community Sciences personnel research scholars, may also be allowed to carry out research pertaining to the areas of cooperation at Dhiraj Hospital, SBKSMIRC, as per Institutional regulations.
 - 3.7. Faculty of Family and Community Sciences may seek assistance/guidance of Dhiraj Hospital, SBKSMIRC faculty member/s in product/process modification, modernization, trouble shooting, etc.
 - 3.8. Faculty of Family and Community Sciences would allow the industrial visits of students to provide them with an exposure to various equipment, instrument, etc.
 - 3.9. Visiting faculty/scientists/research scholars from Faculty of Family and Community Sciences may avail clinical/ pre-clinical facilities, laboratories, library, Internet, computational facilities at Dhiraj Hospital, SBKSMIRC.
- 3.10. A Researchers of faculty at Faculty of Family and Community Sciences may be appointed a Co-research guide as per the rules of the respective institute for a student



- Registered for Ph.D/ PG degree at Dhiraj Hospital, SBKSMIRC. The student may be encouraged to take up the project such that both the parties desirably benefit from its outcomes.
- 3.11. The PG/UG students may carry out part of their research work or project at Dhiraj Hospital, SBKSMIRC and Faculty of Family and Community Sciences depending on the nature of the work as per rules of the respective institute depending on facilities and requirements.
- 3.12. There will be no restriction on the contents of the thesis and on publication of results of the thesis, subject to the condition that no Intellectual Property Rights can be secured for any part of the work which will be decided with mutual consent.
- 3.13. Both Dhiraj Hospital, SBKSMIRC and Faculty of Family and Community Sciences will
 be free to independently carry out follow-up research
- 3.14. If the outcome of a project related to product development, process technology and design etc. which involves matter of secrecy and concern with security of the State and the Country, the same will not be allowed for publication/printing in any form such as Electronically/verbal, etc. If the outcome of a project results into an intellectual property, for which rights can be secured, it will be decided on case to case basis. Similarly, sharing of expenditure in securing such rights and income accrued through royalty etc by the parties under the law will be decided on case to case basis after mutual consultation.
- 3.15. Research supervisors from both the Parties will be the corresponding authors in any publication resulting from the collaborative work. All the efforts put by the student/s as a part of this MoU will be accounted for by way of reporting the work in thesis and/or paper publication except the part for which IPR needs be claimed.
- -3.16. Neither party will publish the work carried out under this MoU without knowledge of the other.
- 3.17. In any of the activities mentioned above, wherever financial aspects are involved, amount, payment conditions, etc. would be spelt out clearly before starting the activity.

3 19 Student Exchange

- Exchange of students will be selected by mutual agreement between two parties
- An exchange student will continue to be treated as full-time student at his/her home institution.
- An exchange student will be considered as full-time "exchange" student at the host institution.
- His/her programme of study at the host institution will be determined by mutual consultation between his/her academic advisor at the home institution and his/her" interim" academic advisor identified by the host institution.
- The host institution will evaluate an exchange student's performance in each course or module, award a letter grade or marks, and issue a letter to that effect.
- The home institution may award to the exchange student credits earned at a host institution, but only after the home institution has established correspondence between courses taken at the host institution vis-a-vis those offered at the home institution.
- If an exchanged student has undertaken research, then the host institution will evaluate the student's performance, and issue a letter to that effect, together with a technical "report" of the research carried out.
- If an exchanged student has undertaken research, then the home institution will take note of the performance evaluation and the technical report, and take steps in accordance with its own procedures.
- Dhiraj Hospital, SBKSMIRC and Faculty of Family and Community Sciences agree to provide suitable accommodation and living expenses for student exchange.
- To avail travel expenses, students can apply for existing funding programs at their respective home universities.

• The exchange students will pay tuition and other fees at their home institution.

- to exchange information on research and educational programs,
- to exchange information on teaching, learning material and other literature relevant to their educational and research programs,
- to jointly organize short-term continuing education programs on topics of mutual interest and to invite each other's faculty to participate therein,
- to propose and engage jointly in research or training programs sponsored by funding agencies, and to invite each other's faculty to participate therein,
- to exchange, on a reciprocal basis, students at Under graduate, Graduate and Doctoral levels for limited periods of time for purpose of education and /or research,
- the provision of cultural and intellectual enrichment opportunities for staff and students of both parties,
- to use laboratory facilities in specific cases for a limited period,
- to permit students, staff and faculty members to use library facility.

3.24. Is divinge of Research Reisonnet

- This MOU is intended, among other objectives, to foster increased interaction among faculty and advanced graduate students engaged in scientific and scholarly research in areas of mutual interest. In support of this effort, each party will promote the exchange of research personnel, especially young faculty and advanced graduate students, for short periods of time so that they may become familiar with the facilities, methodologies, research culture and concern area of cooperation.
- As a general principle, funding for the exchange of such personnel ("Participating Researchers") shall be based on a reciprocal sharing of costs:
- Each institution will provide funding for roundtrip transportation to and from the host institution for its own Participating Researchers.
- Each host institution will provide housing accommodations free of charge, as well as a modest living allowance in accordance with the standard per diem rates established by their governing bodies at the time of the exchange, to the Participating Researchers.



- Each institution will provide assistance, and 'or the necessary letters of invitation or affiliation to facilitate the visa applications of Participating Researchers.
- Individual participating researchers shall be responsible for ensuring adequate medical insurance coverage, applicable in the country of the host institution, for the duration of their visits.
 - Specific funding allocations for this exchange of participating researchers shall be subject to the approval of the institutions.

Intellectual property rights

ě

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both parties to this Memorandum. Both parties shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both parties shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the parties agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing.

Any publication regarding such intellectual property shall only be possible with the prior written consent of both parties, such consent not to be unreasonably withheld.

SVDU shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, clinical and publication purposes without the payment of royalties or other fees to the other party.

Amendments/modifications

This MoU may be amended or modified by a written agreement signed by the representatives of both parties.

Adherence to laws

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the law of the host countries and rules and regulations of the institutions.



Legal effect

Nothing in this Memorandum shall be construed as creating any legal relationship between the parties. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

Commencement and Tenure of MOU

The present MoU shall become effective from the date of signing. This MoU will be renew after every 5 years of tenure while it will be amended/ terminated with mutual consultations and written agreement.

Dispute Resolution

Any dispute or difference arising out of or in connection with the interpretation or implementation of this MoU or out of or in connection with the breach, or alleged breach of this MoU, each Institution shall attempt in the first instance to resolve the conflict amicably by mutual agreement between the two representatives of the organization. Conflicts that cannot be resolved amicably shall be settled by arbitration.

Dhiraj Hospital, SBKSMIRC and Faculty of Family and Community Sciences welcome the establishment of this Memorandum for cooperation and jointly agree to the provisions as set out above.
