MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding made on this **18th** day of **June 2020** at Piparia, Vadodara by and between the,

First Party

Sumandeep Vidyapeeth (an Institution Deemed to be University under section 3 of UGC Act 1956), through its **Registrar, Dr. Chandramani B. More**, Age: 47, residing at Vadodara herein after referred to as the **First Party** (which term shall mean and include wherever the context so requires or admits the company and its successors in interest (his heirs, successors, administrators, executors, attorneys and assigns) of the **One Part**

Second Party

Vaman Trust, bearing Registration No. E/5107/Vadodara, dated: 25th March 1997, at Village: Bahadarpur, Taluka: Sankheda, District: Vadodara, Gujarat through its Chairman/Secretary **Mr. Hashmukhbhai Dashrathlal Desai**, Age 84, having address at 5- Nataraj Nagar, Kaladarshan Char Rasta, WAGODIYA Road, Vadodara _hereinafter referred to as the **Second Party** (which term shall mean and include wherever the context so admits or requires its successors, administrators and assigns) of the other Part witnesseth as follows:

The total administrative expenditure when required from time to time of Bahadarpur hospital will be borne by the First party and to meet with the day to day expenditure for smooth functioning of hospital, the first party will open a Bank account where all income generated from the hospital

will be credited and the total expenditure of the hospital will be debited to it. The First party will administer and operate the account and any deficit therein will be made good by the First party.

This arrangement is initially agreed for 15 years which shall be renewed on every 3 years from time to time.

The earlier MOU ended on 20/03/2020 and it cannot be renewed for three month due to corona pandemic. So, both the party mutually agreed to renew this MOU from today, but the period which was lapsed also be considered in this MOU.

This MOU is effective from 21/03/2020 to 20/3/2023.

Description of full administrative / Academic control

- (1) All the Academic and Administrative control shall be with the Dean of S.B.K.S. Medical Institute & Research Centre (SBKSMIRC) & Dhiraj Hospital, for training the students, interns / residents in Community oriented primary health care and rural based health education for the rural community attached to it.
- (2) Sumandeep Vidyapeeth, an Institution Deemed to be University / Dean, SBKSMIRC & Dhiraj Hospital will provide all required staff e.g. Doctors, Specialists doctors, trained nurses, field workers etc. for better and efficient working of hospital and their duties and working pattern will be decided by the Dean, SBKSMIRC and HOD, Community Medicine, SBKSMIRC,

- (3) All expenses of salary, transport of doctors, Para medical and supporting staff posted by the first party for working in hospital at Bahadarpur will be borne by the first party.
- (4) All the administrative liability of running the centre will be borne by First party that is SVDU.
- (5) The fresh basic local staff like sweepers, technicians, security etc., will be appointed by the first party
- (6) The Second party will provide free quarters for doctors and interns, which are existing today.
- (7) Charges for the OPD and IPD and any other charges to be levied from the patients will be decided by the First party from time to time with keeping in confidence with the Second Party.
- (8) Patients not manageable at Bahadarpur Hospital shall be referred to and managed at Dhiraj Hospital, Piparia or any other Hospital unit of Sumandeep Vidyapeeth after counseling of the patients.
- (9) Transport arrangement for doctors, specialists, paramedical staff, supportive staff and intern doctors will be made by the First party.
- (10) For any expansion of new machines / equipment if required, than it will be installed by the First party, will be the owned by First party, will be maintained by the First party and the First party reserves the right to take back such machine/ equipment. The ownership of new machine installed if any, by the first party, for the expansion/ extension of Health services, will remain with the First party, will reserve the right to dispose off/ take the machine / equipment back.

The existing board of Trustee of the Vaman Trust and Members who are appointed by the trust will not be disturbed and will continue to function as hitherto and will participate in the development of the hospital.

First party will utilize the existing properties of the Bahadarpur hospital (including all basic facilities, furniture's, instruments, equipment, residential and ambulance facilities etc.) for providing medical and health care to the needy people. The hospital facilities will also be used for training of interns and resident doctors to provide better trained doctors.

Sumandeep Vidyapeeth shall strengthen the existing facilities by providing required furniture's, instrument/ equipment, manpower, medicine, dressing material and financial inputs as and when required from time to time.

(12) Changes if required shall be made in case papers / OPD papers.

(13) There will be a quarterly (January, April, July, and October) - meeting of Dean, HOD and trustees to review the progress and to be submitted to the First Party Sumandeep Vidyapeeth.

(14) Any dispute, if arises, should be resolved by amicable discussion at the Dean and Trust Administrative level.

(17) In future if the agreement breaks up or is terminated, the First party is liable to pay or clear all the dues including government dues.
