- 3.3 Authorship of results of the research projects in publications will be determined in accordance with academic standards, UGC norms and by mutual understanding of the investigators of all the participating Institution.
- 3.4 Either Institution will not disclose any part of such information to any third party without obtaining the prior written consent of the other Institution.
- 3.5 Investigators and students of both the Institutions will equally share clinical and non-clinical research infrastructure after obtaining formal permissions as required.
- 3.6 Neither Institution is responsible for any financial support under this MOU. Individual scholars will make all arrangements by written agreement, which will be applicable to each particular situation.

- 3.10 With regard to intellectual property, each Institution will adhere to the intellectual property laws. Intellectual property developed during the visit of a faculty or student will be governed by the rules of the host Institution unless otherwise specified by an alternate agreement. In general, the two Institutions shall jointly own the developed intellectual property resulting from clearly defined collaborative projects.
- 3.11 The various projects/activities under this MoU may be administered by the coordinator(s) to be appointed by the SVDU and LMCST (Pharmacy). Further, both institutes may enter into specific written agreements under authority of this MOU to clarify and define the nature, extent and terms of operation for the particular projects, giving the project title; scope; roles and responsibilities including intellectual property ownership and funding issues, if necessary.

#### 4. Commencement and Tenure of MOU

This MoU shall become effective from the date of signing of the document by both the Institutions herein. It shall remain in force initially for a period of five years and can be amended/ terminated at notice of 3 months from either Institution with mutual consultations.

#### 5. Dispute Resolution

Any dispute or difference arising out of or in connection with the interpretation or implementation of this MoU or out of or in connection with the breach, or alleged breach of this MoU, each Institution shall attempt in the first instance to resolve the Dispute through friendly consultations.
