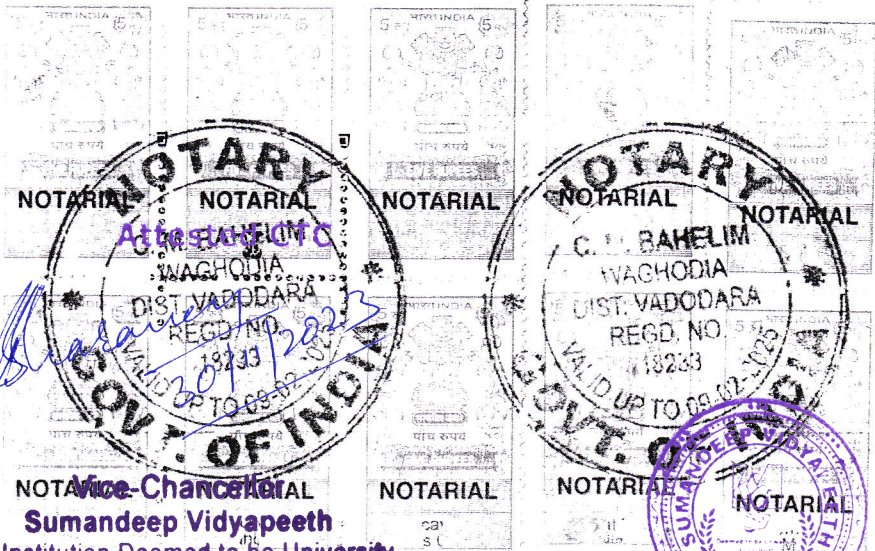

Memorandum of Understanding

The Memorandum of Understanding (MoU) is signed on 19th April 2021

Between

Sumandeep Vidyapeeth Deemed to be University,

At Post Piparia, Taluka Waghodia, District Vadodara, Gujarat state, India.

(Hereinafter referred to as **SVDU**)

And

The Banyan City Jaycees Education Trust

(Spandan School for Mentally Challenged Children)

(Hereinafter referred to as **TBJCET**)

This MoU is for establishing the collaboration between SVDU and TBJCET, especially for Persons with Disabilities (PwD), in the area of **Rehabilitation Services, Health Care Services, Joint Research and Innovation Projects / Studies, Joint Programs / Courses, Incubation Centre, Startups, Community / Social Service, Joint Health checkup and Treatment camps, Joint Conferences / Seminars etc.** The collaboration between both the parties herein under, is based upon the principles of mutual interest.

Preamble

About SVDU:

Sumandeep Vidyapeeth Deemed to be University was notified through Gazette Notification of Ministry of Human Resource Development (MHRD), Department of Higher Education, Government of India, through vide notification No.F.9-46/2004-U.3 dated 17th January 2007, as '**Deemed to be University**' under *de novo* category. The Vidyapeeth was established under Section 3 of the University Grants Commission (UGC) Act, 1956 through vide Notification No. F.No.6-106/2004 (CPP-1) dated 9th March 2007, and vide Notification No. F.6-106(1)/2004 (CPP-I) dated 26th August 2008. The MHRD through its notification no. F.9-46/2004-U.3 dated 16th December 2019, has extended the '**Deemed to be University status**' for Sumandeep Vidyapeeth, from **17th January 2012 onwards**. The Institution is accredited by National Assessment and Accreditation Council (NAAC) at '**A**' Grade with CGPA of 3.53 at Four-point scale, and is also conferred with **Category - I Deemed to be University status**, by University Grants Commission (UGC).

Certificate, Diploma, Graduate and Postgraduate Degree, Super Specialty, Doctoral (Ph.D.), Post – Doctoral, Value Added Courses, Interdisciplinary programs, etc. in the disciplines of Health such as Medical, Dental, Pharmacy, Nursing, Physiotherapy, AYUSH, Healthcare Management, Public Health, Paramedical, Audiology & Speech Language Pathology, etc. These Programs are recognized / approved by Statutory Regulatory Authorities (SRA) such as related Councils - Medical Council of India, Dental Council of India, Pharmacy Council of India, Indian Nursing Council, Rehabilitation Council of India etc., and University Grants Commission. The Institution has following Constituent Institutes / Constituent Departments at Piparia, Vadodara campus:

Sumandeep Vidyapeeth Deemed to be University has more than 1100 bedded multi - speciality tertiary care Dhiraj Hospital, 350 Hi-tech Dental Chair Hospital and State-of-art Central Research and Innovation Laboratory, and Incubation Centre. These Hospitals cater to the needs of Local population. Patients from Madhya Pradesh, Rajasthan and Maharashtra, and Tribal Districts of Gujarat. The Dhiraj Hospital has a state of art Cancer Diagnostic and Treatment facilities. The Hospital is the major source of Clinical and Academic Research for the Teaching Faculty, Researcher and Students of the Institution. The Molecular Laboratory is NABL accredited and approved by State Government and Indian Council for Medical Research (ICMR) for COVID19 testing facility. The Dhiraj Hospital is designated by Government of Gujarat, for the management of COVID19 infected patients.

About Department of Audiology and Speech Language Pathology, SVDU:

Department of Audiology and Speech Language Pathology (DASLP), constituent Department of Sumandeep Vidyapeeth Deemed to be University was established in 2019, with due permission of Rehabilitation Council of India (RCI). The Department offers Educational Programme in Bachelor of Audiology and Speech Language Pathology (B. ASLP), and Diploma in Hearing Aid Repair and Ear Mould Technology (DHAREMT).

The Clinical Section of the Department undertakes Rehabilitation Services for Persons with Hearing and Speech Language Disability, from last 6 years at Dhiraj Hospital, SBKSMIRC. The Rehabilitation services in the hospital does not limit to the following:

- (1) Evaluation and treatment of hearing loss and tinnitus (2) Assessment and Rehabilitation of auditory and balance disorder (3) Provision of hearing aids, assistive and alerting devices (4) Post Cochlear Implant management (5) Evaluation and treatment of speech, language, voice, and swallowing disorders (6) Rehabilitation for Speech Language Pathology.

About TBJCET

The Banyan City Jaycees Education Trust was established in 1975 and started Spandan School for Mentally Challenged beginning with only 12 children and 2 special educators. Since then, Spandan has grown into an integrated facility. Spandan is a part of Banyan City Jaycees Education Trust bearing registration no. F-150 dated 14/8/1975 Under the head of Spandan School, TBJCET offers various specialized therapies and programs for both physical and mental development, all available in a centralized location and at a subsidized rate. It is the first centre in Vadodara that started care and education of Children with Mental and Physical Disabilities and has now grown to almost 200 beneficiaries and more than 40 staff. The individuals with Intellectual deficits are given therapy, education and training as per their age and mental capabilities to make them as independent as possible in taking care of themselves in day-to-day life.

Scope of the Collaboration

Especially for Persons with Disabilities (PwD), in the focused areas, such as **Rehabilitation Services, Health Care Services, Joint Research and Innovation Projects / Studies, Joint Programs / Courses, Incubation Centre, Startups, Community / Social Service, Joint Health checkup and Treatment camps, Joint conferences / seminars etc.**

General Areas of Cooperation

This MoU will govern the relationship between the SVDU and TBJCET regarding Rehabilitation Services to Persons with Disabilities (PwD) of any age.

Both SVDU and TBJCET shall encourage interactions among Clinicians, Teaching Faculty members, Non-Teaching Staff, Students and Children/Patients through the following arrangements, but not limited to:

1. For the management of Persons with Disabilities (PwD), having Cerebral Palsy, Audiology and Speech Language disorders, Autism, ADHD, Down's syndrome and other types of Intellectual Disabilities, etc.
2. Clinical Screening and Assessment of various Impairments in PwD and normal individuals.
3. Medical and Rehabilitation camps to be organized jointly for PwD and normal individuals, if any.
4. To jointly participate in the development of an individual education program for school age children.
5. To undertake research projects / studies as needed for PwD.
6. To undertake or devise new aids / equipment's required for Persons with Disabilities (PwD), and to Patent / Copyright the same, either individually or jointly.

Confidential Information

SVDU and TBJCET agree for not disclosing any type of confidential material, knowledge, study results or information. The parties may like to share this with one another but may decide not to disclose it to any third party. In the event if it is required to be shared with a third party, except as an when required by law; then mutual consent in writing must be obtained from the other party, prior to disclosure. This Non-Disclosure Agreement (NDA) creates a confidential relationship between the parties to protect any type of confidential and proprietary information or trade secrets.

Intellectual Property Rights

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both parties to this Memorandum. Both parties shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both parties shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the parties agree to each a separate agreement covering issues such as exploitation rights and revenue sharing.

Any publication regarding such intellectual property shall only be possible with the prior written consent of both parties, such consent shall not to be unreasonably withheld.

SVDU shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, clinical and publication in scientific journals, the purposes without the payment of royalties or other fees to the other party.

Amendments / Modifications

This MoU may be amended or modified by a written agreement signed by their representatives of both parties.

Adherence to Laws

Participating Teaching Faculties, Non-Teaching staff and students involved in any activities under this Memorandum must adhere to the law of the country and rules and regulations of the Institution.

Legal Effect

Nothing in this Memorandum shall be construed as creating any legal relationship between the parties. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

Commencement and Tenure of MOU

The present MoU shall become effective from the date of signing. It shall remain in force for the period of Three (3) years i.e., from 19th April 2021 till 18th April 2024. This MoU will be amended / terminated with mutual consultations and written agreement, as and when needed.




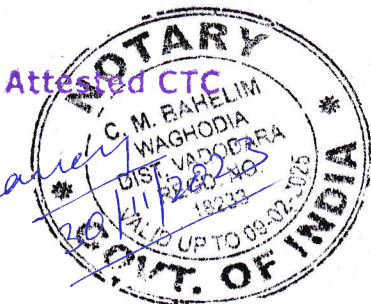
Dispute Resolution
