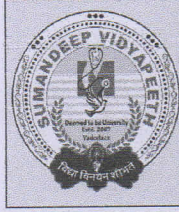

4. Type of Questions : Single response Multiple Choice Questions (MCQs)
5. Total number of MCQs: 100
6. Maximum Marks: 100
7. Duration of Examination:100 Minutess
8. There will be No Negative Marking.


